911: Dave introduced new assistant - Kate. Phone integration has started and should be completed by end of October (digital). New servers are being worked on and are in test phase. Upgrading CAD and next upgrade will include mapping improvements. 911 texting should be up and running in October. There has been a need to tweak Active 9911 interface and mapping should now be working on Androids. Message section has been customized to give more information - especially for medical calls. Med Flight interface is now on each consoles. App can now be loaded in phones of designated individuals. Need to talk to Ken Nemes (574-647-3473). This app is NOT for Aircare.

Emergency Management: Rocky advised that for active violence event PD's need to take advantage of fire to set up command post. Need to know how each department will address medical/fire response into hot zone to control bleeding. Presently the stopping point until this is determined countywide. Rocky will set up meeting with EMS and possible PD and Fire to move forward with how to respond and who will do what.

EMS: Frank Back to Emergency Management discussion. Medic and SMACAs have some people trained in truma for hot zone. Medic will go in with PD to warm zone (in general but not company policy). SMACAS policy right now is not to go in, but some will. Staging has to be closer and may be in warm zone.
