<u>SHERIFF-</u>. The Sheriff discussed their efforts this season to keep the beach family friendly. Teaming up with St Joe Public Safety. Red BudDDD International event effort being planned as well as getting ready for the Youth Fair. He reminded everyone that his department only has 2 Deputies assigned to the fair. All of the others are volunteers giving back to the community. Finally the Life Rings were briefly discussed. Both the SD and SJPS officers are checking to make sure they remain ready to go.

<u>911</u> –.Director Agens is preparing to sign an MOU to take responsibility for the Niles Communication Equipment with the State and Motorola making any repairs. Dave discussed future charges pending on colocation of VHF equipment on State Towers. He is proposing to move New Buffalo City and Township to 800 pagers now. The initial proposal would be 911 to fund 50% of the cost of the new pagers. Benton Harbor City is having good luck so far with the new system and Saint Joe City is in the planning stages to migrate soon. Dave wants to be fair with all agencies. The group felt that with the issues in the New Buffalo area it made financial sense to help fund this move. It would provide long term savings by illuminating the need for at least one phone link saving money in the long run. Plans are still in the works for another run at the large grant when it's again released.

Chief Heyn discussed interference that he has been having. Dave said that it was most likely interference in the area and that short of calling the FCC not an easy fix. Colocation agreements could cause issue. VHF competing with a stronger system. Simulcast helps this issue. Sumnerville Tower to Bertrand Tower microwave link radios require replacement. Clocks will also soon need to be replaced at a sizable expense.

<u>Funeral Protocol</u> – 150 badge straps ordered.

EMERGENCY MANAGEMENT/LEPC —..Sgt Bush discussed flooding and the United Way long term recovery work group to fund and meet unfunded needs. Application for low interest loans has closed. After Action report request from Rockey has been sent out. Please look it over and fill out any sections that applies to your organization. Moving forward with BWarn. Active Violence Deputy Albers working with RTF development. 5 people are going to Train the Trainer.

LEPC had Dr. Harvey Barnett speak on responder mental health and the availability of the County CISM team when we need them.

<u>TRAINING-</u> Dave Albers presented a survey and instructions for proposed training needs. Please turn it in to let them know what you would like to see in the way of future training in our County. Courage to be safe, First Aid can be presented by training or Aaron Floor in Niles Township.

August 4 at St Joe High School a "Pride in Ownership" with Nationally Acclaimed instructor Chief Lasky with Lunch also provided.

Proposed schedule for future FF1&2 is now out. The committee decided to present the bulk of the class on the weekends with the option of Days being provided in Cass County on Tuesday and Thursday.

<u>FAIR-</u>Both Gerry and Bruce are still looking for help with Fire Prevention and Standby and inspection services.



Access public-safety applications designed to streamline information sharing for you, your family, and/or facility staff during an emergency.

Build your own private/household profile to share only with public-safety personnel when you call 911. It is nationwide and will go anywhere your mobile phone goes, and connect with any participating local Public-Safety center when you call 911.



Build a facility profile for your organization that will provide publicsafety with important location directions, facility contacts, and hazardous materials lists, even when 911 is called by a mobile device from the facility.



Register to receive priority notifications regarding the Berrien County locations you are most interested in during a local emergency, and pre-register for special needs services during a disaster.



Keep in mind, these applications are offered as a part of a comprehensive county public-safety 9-1-1 and public notification system. While they are a powerful and convenient critical-information sharing approach, they will perform only as well as the wireless services and public internet.
