Response time approximately 30 minutes. Respond in teams of two. Staff will have identification on ID lanyard. The VSU is available for victims, families of victims, as well as first responders. VSU will be attending National Night out and be at the Berrien County Youth Fair. The Under Shariff advised the VSU is a great resource and thanked them for their service.

EMS:

Medic-1: Chief Weich discussed the expansion of Medic-1 in the north county due to PrideCare no longer operating in Berrien County. Medic-1 was overstaffed now under staffed. Looking to add two additional 24hr staffed units, with possibility of a third.

S.M.C.A.S.: None

Med Flight: Mark stated Med Flight has moved to Elkhart airport as of June 01, 2023. Move will add 10 minutes to responses. LZ classes available.

Med Control: Al discussed the no bag policy that has started at Corwell. Have a metal detector in the ER. Asked EMS services to advise patients and families to leave bags/purses at home or in vehicles. Construction continues.

Funeral Protocol: Berrien Springs.

Dispatch: Tower moving forward. Still waiting on ground study. Have 1 dispatcher in training, and 3 call takers in training. Still have 4 openings. Completed radio training with SJCDPS reserves. Received fire dispatch training at 911 conference. Will be attending the MI-MABAS 101 training in future. Discussed training on MADAY and requested MADAY policy. Discussed the use of 11PG911 for dispatching multiple departments. BC Dispatch has a couple departments that have 5 agencies on initial dispatch. Use of 11PG911 and initial dispatch moved to communications committee. Discussion on radio traffic. Still many departments having most if not all apparatus announce to dispatch they are enroute/on scene, etc......BC dispatch needs to know the following: Agency clear the call; first unit enroute; first unit on scene; when clear the scene. All other unit radio traffic should be with agency/scene command.

BC dispatch willing to have agencies come to dispatch and see how dispatch works. BC Dispatch held a training with SJT station 1. Went very well. BC Dispatch willing to come to FD for training.

MABAS: Will be hosting a Legislative Day on August 18, at the MOB, in Holy MI. The focus will be MI-MABAS vision, purpose, capabilities and recent responses with demonstrations. Michigan MABAS will be taking over the ordering, receiving and dissemination of the Emergency Response Guideline. Plan Coordinators Meeting - on-going discussion of EMS boxcards and AVI response. The Region 3 Technical Response Team, Divisions 3301 and 3302, was validated in Confined Space and Rope Rescue Technician Level in May. Also, the newly formed Grand Traverse and Otsego Hazmat Company, Division 3701, was validated as a Type II in June. MI-TF1 has started the process of developing an internal UAS Capability. MITF1 has sent a swift water rescue team to Vermont for the flooding.

Old Business: Discussion on the BCFCA meeting time survey that was sent out. Due to the clos numbers VP Flick tabling it until executive board can meet to discuss. 16 for morning meeting. 11 for evening meeting. Remember new bylaws allow for agency to delegate an authorized representative if Chief unable to make BCFCA meetings.

New Business: Discussion on holding the August BCFCA meeting at the BCYF. We have been holding the August meeting there for some time now so continue having August meeting at the BCYF. Discussion on creating a committee to create a MADAY procedure for the county. Question on this discussed previously. Sec./Treas. DeLaTorre discussed MI-MABAS had created a MAYDAY policy at the request of our and many other divisions that were in same predicament we are, with no MADAY policy or needing an updated one. BCFCA formed a committee in January 2022 of MABAS department to review the MI-MABAS draft MAYDAY policy/procedure. Approved MI-MABAS MAYDAY policy/procedure was brought back to the body at the May 2022 meeting. Committee of: Chief Weich, Chief Chairello, Chief Whitney, Capt. Kniesly, and Caitlin to look at MI-MABAS MAYDAY policy/procedure and work on MAYDAY policy/procedure for our county.

Justin turner brought BCYF fire coverage. Has schedule with him if interested.

Chief Weich mentioned good job to New Buffalo City Fire on calling out hydrant location for structure fire this morning.



What the Berrien County Victim Services Unit Is and What We Do

The Berrien County Victim Services Unit is a trained volunteer group under the direction of the Berrien County Sheriff's Office and the Michigan Sheriff's Association.

Dedicated to helping victims, survivors and their loved ones work through a crisis or crime, we are the helping hands of the police, fire and medical personnel.

Our presence frees authorities to do their job without leaving victims alone or feeling ignored.





The Victim Services Unit is designed to comfort and help victims immediately after an incident by providing short-term crisis intervention. Having no previous experience in traumatic events, most victims feel lost and in need of guidance.

We can offer answers to such common questions as what happens next, funeral preparations, why an autopsy is needed, why a crime scene takes so long to process and who will guide them through the court system.

Referrals can also be made to appropriate agencies and services within the community.

On scene, **VSU** plays a vital role by lending support and assisting victims and witnesses through the initial shock of trauma. We can separate victims from the scene of an investigation while maintaining a link to officers for victim's questions and concerns.

At a secondary site, **VSU** can stay after the officers leave, working to pull a support system of close friends, family or church personnel into place.




Great Lakes Rescue

Response Review







On July 12th, 2023 GLR responded to St Joe County to assist in damage assessment at night from an EF1 tornado touchdown. Working with local Fire and SJCSO we were able to further evaluate the extent of damage from thermal imagery and aerial spotlights to assist responders in their mitigation of the incident.
