

Benefits of the Blue Card Program

- Injury Reduction The Blue Card Command Certification
 Program standardizes incident command and control, improves fireground safety, and reduces firefighter injuries on the
 fireground. It is referenced in recent NIOSH LODD Reports.
- Cooperation There are instances where Blue Card Certification supported inter-jurisdictional responses between departments that did not share a mutual aid agreement.
- 3. Standardization The Blue Card Command Certification Program delivers consistent training that puts everyone on the same page. Our standardized training provides standardization within a department, mutual-aid system, or regional response zone.
- 4. Value a Company Officer enrolled in the program receives between 42-50 hours of command training and an additional 12 hours of Continuing Education for \$385.00. That total is \$6.20 per training hour for all participants.



"Standard Operating Guideline for Radio Traffic Review & Communications Enhancement"

Effective Date: 2024/11/13 Last Reviewed: 2024/11/12

A. Purpose

The purpose of this guideline is to establish a standardized procedure for the Communications Committee to review radio traffic from the fire department and public safety agency response to calls for service. The goals are to identify areas for improvement, ensure compliance with protocols and regulations, enhance operational efficiency, and maintain high standards of communication and public safety.

B. Scope

This guideline applies to all members of the Communications Committee, Dispatch Center personnel, and public safety agencies within Berrien County that are dispatched to calls for service. Neither the Communications Committee nor the Berrien County Fire Chiefs Association has authority over individual agencies, but serves in an advisory capacity to enhance safety and communication effectiveness through structured reviews and recommendations.

C. Definitions

- 1) Radio Traffic: All verbal communications transmitted over the radio during a fire department's response to an incident.
- Review: The process of listening to and evaluating recorded radio traffic to assess communication effectiveness.
- 3) **Complaint:** A formal concern was raised regarding communication during fire department operations.

D. Criteria for Review

A review of radio traffic will be warranted under the following circumstances:

- 1) **Critical Incidents:** Incidents involving loss of life, injuries to firefighters, or major property damage.
- 2) **Near Misses:** Incidents involving an unintentional incident that could have led to injury, death, or property damage.

- 3) Unusual Circumstances: Calls involving hazardous materials, complex rescues, mass casualty events, or multi-agency operations. May also include incidents that involve unique or unprecedented circumstances, such as new technologies, tactics, or procedures.
- 4) **Training & Development:** Calls that highlight areas for improvement in radio communication training or protocols.
- 5) Complaints or Concerns: Complaints or concerns submitted by fire personnel, other agencies, or the public regarding radio communication, or at the discretion of the Communications Committee.
- 6) **Communication Errors:** Suspected breakdowns or inefficiencies in communication during an incident.
- Regulatory Compliance: Ensuring adherence to federal, state, and local communication regulations.
- Legal or Ethical Issues: Incidents involving potential legal or ethical concerns related to radio communications, such as privacy violations or inappropriate language.
- Routine Quality Checks: Randomly selected calls for service to evaluate ongoing communication effectiveness.

The committee will use its discretion to determine whether a particular incident warrants review based on the criteria listed above and the overall goal of the review process.

E. Review Process

1) Requesting a Review:

- Reviews may be initiated by the Communications Committee, the Dispatch Center, the Chief Officer (or an authorized representative) from a public safety agency when any of the above criteria are met, including in response to specific complaints.
- A formal request should be submitted in writing, specifying the incident and reason for the review (see page #5).

2) Obtaining Audio Recordings, Information, & Context:

- The Dispatch Center will provide the Communications Committee with the relevant audio recordings as soon as possible after the request is made.
- When possible, members of the Communications Committee may participate in or receive summaries from incident debriefings and/or interview personnel involved in the incident. This approach allows the committee to align its radio traffic review with the broader context of the incident and better understand any on-the-ground challenges that may have influenced communication.

3) Reviewing the Audio:

- The Committee will listen to the radio traffic as a group, assessing:
 - Clarity and Intelligibility: Whether communication is clear and understandable.
 - Timeliness: Whether communications are timely and appropriate for the situation.
 - Protocol Adherence: Whether established radio protocols and procedures are followed.
 - Coordination and Collaboration: Whether there is effective coordination between fire units, dispatch, and other agencies.
 - Public Safety Impact: Whether the communication contributed to public safety and the successful resolution of the incident.

· Specific issues to look for include:

- Misunderstandings: Instances where messages were misinterpreted or misunderstood.
- Delays: Any delays in communication or response times.
- Protocol Violations: Non-compliance with radio procedures.
- Operational Inefficiencies: Situations where communication may have caused operational delays or issues.

F. Complaint Handling and Documentation Process

- 1) **Complaint Submission**: Complaints related to communication issues during fire department responses may be submitted by members of the Berrien County Fire Chiefs Association.
- 2) **Review and Investigation:** The Communications Committee will document the complaint and initiate a review of the relevant radio traffic and any other pertinent information.
- 3) **Report Preparation:** A written report will be prepared within 90 days of a written request for review summarizing the review findings, including identified communication strengths, weaknesses, and areas for improvement. Audio files may be included when available.
- 4) **Report Distribution:** The report and audio copy will be sent to the department in question, the Berrien County Fire Chief's Association, and other involved parties. (See "Communications Review Report" after page 5 of this document).
- 5) **Recommendations:** The report will include recommendations for improvement to address the identified issues.

G. Follow-Up Actions

1) Implement Recommendations:

 The Communications Committee will work with public safety agencies and the Dispatch Center to implement any necessary improvements in communication practices, protocols, or equipment.

2) Training and Education:

 The Committee may recommend additional training or education for emergency responders to enhance their radio communication skills.

3) Incident Debriefing Integration:

 The review findings may be integrated into post-incident debriefings to provide realtime feedback and identify immediate opportunities for improvement.

5) Cross-Agency Collaboration:

 The Committee will coordinate with other agencies involved in multi-agency responses to ensure communication protocols are harmonized and effective.

6) Continuous Monitoring:

The Committee will continue to review radio communications to identify effectiveness
of training and areas for improvement.

7) Feedback and Revisions:

 Departments are encouraged to review the recommendations and provide feedback to the committee. The committee will consider this input for any further actions or revisions to the guidelines.

H. Confidentiality

All audio recordings, complaints, and review findings are to be treated as confidential. They should only be shared with individuals involved in the review process or as required by law. When appropriate, information and documentation may be used for training purposes.

I. Approval

This guideline has been reviewed and approved by the Berrien County Fire Chiefs Association on 2024/11/13.
