Chief Myers stated the accountability app is completed and in the apple app store. Demo later.

Discussion on what measurers dispatch has in place to review 11BCPAGE use and assigning 11FG for confirmed structure fire.

There have been several structure fire calls where departments are asking for 11FG instead of them assigned in the dispatch.

Use of 11BCPAGE, there have been several times only hearing departments clear the call and never heard department get dispatched. LT DeLaTorre advised he has 5 radios set to 11BCPAGE two in Niles and three in Coloma.

Caitlin was not present to give input.

Communications Committee wants to remind Chiefs to remind their members to carry their pagers. There have been several times where a department gets disregarded and few minutes later someone from the department is clearing the call. Is this an issue of relying on active911 instead of carrying pager?

Question on excessive radio bonks since move to simulcast. BHDPS has had an excessive amount of bonks since move to simulcast.

Niles has issues with pager reception at fifth and main area since move to simulcast. Discussion on reminder for departments to have 800 radios tuned and aligned on regular basis. MPSCS recommends tune and align annually.

Discussed letter to politicians on boarder radio issues with Indiana. Chief Weich requested addition of MPSCS to letter. Revision sent to Chief J. Flick.
